Application Fee	\$100.00 per New Family applying for admission to St. John's School. <b>Fee is due with application.</b>
Registration Fee	\$100.00 per child (Registration includes Archdiocesan Student Assessment of Catholic Religion Education, Standardized Testing, ADW Technology fees, Middle States dues and the Archdiocesan Marketing Program, CSO Fee, Marketing Fee.) <b>Due within two weeks from acceptance</b> <b>REGISTRATION FEE INCREASES TO \$150.00 after two weeks past acceptance.</b>
Instructional Fee	\$180.00 per child (Fee is reduced by State Textbook Funding) (Includes but not limited to: instructional materials, textbooks, manipulatives, technology supplies, consumable supplies and classroom copying.) <b>DUE BY 6/7/11(separate check payable to St. John's School)</b>
Medical Support Fee	\$40.00 per child (Fee supports part-time Health Room Medical Technician) <b>DUE BY 6/7/11 (separate check payable to St. John's School)</b>

After this application is completed, the family can complete a St. John's Scholarship Application. **Financial assistance must be renewed annually.** (Archdiocesan Policy 4000)
