**PAYMENTS TO BE REMITTED ON-LINE VIA TADS**

- Admission Fee            \$150.00 per New Family applying for admission to St. John’s School. **This is a one-time fee. Fee is due with on-line Application via TADS .**
- Registration Fee        \$125.00 per child (Enrollment includes, Scantron Assessment Fees, Cognia(accreditation) dues, Marketing Program, CSO Student Assessment Fee, CSO Development Fee, Systemic Technology.)  
**Fee is due with on-line Enrollment via TADS. Deadline – 03/18/22**  
**ENROLLMENT FEE INCREASES TO \$200.00 on 3/19/22**  
**\*\*New Families must pay Enrollment fee within two weeks of acceptance\*\***
- Instructional Fee        \$210.00 per child (State Textbook Funding) Includes but not limited to: Instructional materials, textbooks, software upgrades, instructional manipulative (hard/on-line)and resources. **DUE BY July, 2022 via TADS**
- Technology Fee         \$150.00 per child – (Technology support staff/upgrade licenses, operating systems, maintenance of infrastructure/computers/website management) **DUE BY July, 2022 via TADS**
- Medical Support Fee    \$80.00 per child (Fee supports Health Room RN)  
**DUE BY July, 2022 via TADS**
- Home & School Assoc. Fee    \$50.00 per family (Student activities, i.e., Field Trips, Student Appreciation Day, Field Day)  
**DUE BY July, 2022 via TADS**

**Tuition Assistance/Scholarships**

Families in need of financial aide **MUST** first seek aide through the completion and submission of the Archdiocese of Washington Financial Aide Application via *TADS*. **Financial Aide must be renewed annually.** (Archdiocesan Policy 4000). Families that are seeking multiple-child family scholarships **MUST** file a financial aide application with the Archdiocese of Washington then subsequently a St. John’s Tuition Scholarship Application.
