Contract for the Summer Program-2023 (MANDATORY FORM)

I agree that when using the Summer Enrichment Program, the fee is fixed regardless of the number of days my child(ren) actually use(s) the service during the week unless a reduced contract is agreed on. All accounts will be paid on a weekly basis in the form of cash or check directly to the school. Receipts will be provided.

Since absenteeism and emergency days are unplanned and unpredictable, the weekly fee will not be adjusted. I also understand that the Registration Fee is Non-Refundable.

I agree that if my account becomes one week delinquent, or if I do not meet the program's financial requirements, that my child(ren) may be removed from the program and not allowed to return. If removed, I understand I will be responsible for full payment of the account. The decision to remove any child(ren) will be decided by the Directors of the program along with the Principal.

I agree to keep the Program Directors aware of any medical problems or issues related to my child(ren)'s health. A written order from a physician or Dentist must accompany ALL medication to be administered including "over the counter drugs". Proper Medical forms can be obtained from Program Directors. The form must be dated and medication must be identified, in the original prescription container, along with the proper dosage, time of day to be given, anticipated duration of treatment and side effects. A record of all medications dispensed during the Summer Enrichment Program will be kept on file. All medications will be under the control of the Program Directors and kept locked at all times. I also agree that if my child(ren) becomes ill or needs medical assistance that a designated person or I will promptly pick-up my child(ren) for the necessary medical care. In the event of a life threatening medical emergency, I authorize the Summer Enrichment staff to seek whatever necessary medical care that they deem is required for my child(ren)'s well-being and that I assume full liability for the medical care provided.

The late fee for pick-up after 5:30 PM will be \$20.00 per child for the first 15 minutes and \$25.00 per child for each 15 minute period or fraction thereafter. After 6:00PM, the late pick-up fee will double.

I have carefully read this Contract, understand, and agree to my obligations under this Contract. I agree that I will meet all my obligations as detailed in this contract.

What We Do

St. John's School is offering a Summer Enrichment Program for all registered St. John's students. There will be an academic piece as well as a STEM program included. We will also have weekly field trips, as well as weekly pool visits. The Program will be open from 7:30 am to 5:30 pm. There will be healthy breakfasts and healthy snacks. Scheduled activities will be from 9:30 am to 5:00pm. Each week will have a different theme. The weekly themes are listed below.

- Week 1 - July 3th: Independence Week

- Week 3- July 17th: Wild Week
- Week 4- July 24th: History Week

Daily Schedule

This is a tentative schedule of activities. On Field Trip days, the schedule will be different. Some of our planned field trips include visits to farms, zoosafaries, museums. We will visit Allentown Pool once a week.

Fee Schedule

- \$150.00 registration per family
- \$ 50.00 Snack Fee p/child
- \$250.00 per week for 1st child
- \$200.00 Per week Child
- 3 weeks or more \$225.00/175.00

Discount will be applied if child(ren) register for more than two weeks. Other weekly schedules are available upon request.

Field trips are not included in the costs. It is estimated that field trips will cost approximately \$30 - \$40 per trip, depending on location and number of children attending and cost of bus.
