Admission Fee \$150.00 per New Family applying for admission to St. John's School. **(one time fee)**  
**Fee is due with on-line Application via TADS .**

Registration Fee \$150.00 per child (Includes Cognia Accreditation dues, Marketing Program, CSO Student Assessment Fee, CSO Development Fee, Asbestos and Lead Water Inspection fee, TADS Fee)  
**Fee is due with on-line Enrollment via TADS. Deadline – 01/26/24**  
**ENROLLMENT FEE INCREASES TO \$250.00 on 1/27/24**  
**\*\*New Families must pay Enrollment fee within two weeks of acceptance\*\***

Instructional/Book Fee \$210.00 per child (Includes instructional materials, textbooks, instructional manipulatives, on-line resources)  
**DUE BY July 2024 via TADS**

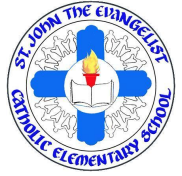
Technology Fee \$250.00 per child (Includes upgrade of interactive display boards for all classrooms, license renewals, maintenance of infrastructure/computers/website management; software upgrade)

Medical Support Fee \$80.00 per child (Supports Health Room RN, medical supplies)  
**DUE BY July 2024 via TADS**

Home & School Assoc. Dues \$75.00 per family (Supports student activities including offset cost of field trips, field day)

### **Tuition Assistance/Scholarships**

Families in need of financial aide **MUST** first seek aide through the completion and submission of the Archdiocese of Washington Financial Aid Application via **TADS**. **Financial Aid must be renewed annually.** (Archdiocesan Policy 4000). Families that are seeking multiple-child family scholarships **MUST** file a financial aid application with the Archdiocese of Washington then subsequently a St. John's Tuition Scholarship Application.
